WHO CAN APPLY

- ♦ Applicants must be at least 9 years old. Eligibility ends one year after graduating High School.
- ♦ Must be an active member of a 4-H or FFA program in Colusa or Glenn County.

APPLICATION REQUIREMENTS

- ♦ Approved loans are funded after loan documents are signed in our office, by the student and a co-signing parent.

GUIDELINES

- ♦ Loans are made on a one year term basis.
- ♦ Funds provided for these loans must be used for the purchase of a market animal and those expenses associated with the project.
- ♦ Upon sale of the market animal all loan funds dispersed are due prior to the loan maturity date.

APPLICATION PROCESS

- ♦ Applicants are required to submit a completed application to one of our branch offices located in Colusa or Willows.
- ♦ Approved loans are funded after loan documents are signed in our office, by the student and a co-signing parent.
- ♦ After documents have been signed and checked by our legal department they are sent to the accounting department where they are set-up and booked. At this time loan funds become available.
- ♦ Checks will be ready for pick-up the following day after booking.
